



## **Malaysians Have Voted! Online Survey Terms and Conditions**

### **1. The Online Survey**

- 1.1 **Malaysians Have Voted! Online Survey** ("Survey") is an online survey held by AEON BIG (M) Sdn Bhd ("AEON BiG or "the Organiser").
