

**CSK ISERLOHN KITCHEN KNIVES COLLECTION REDEMPTION PROGRAMME
REDEEM & REWARD CONTEST
Terms and Conditions**

1. The Contest

Redeem & Reward Contest (“Contest”) is organised by AEON BIG (M) Sdn Bhd (“AEON BiG” or “the Organiser”). This Contest will commence on 4th January 2019 and ends on 25th April 2019 (“Contest Period”). Any entries after the Contest Period shall not be entertained by the Organiser.

2. Contest Eligibility
