

TERMS AND CONDITIONS
6th Fun-Tastic Birthday Bash Contest

1.0 Contest Period

- 1.1 6th Fun-Tastic Birthday Bash Contest (“Contest”) is jointly organised by AEON BiG (M) Sdn Bhd (“AEON BiG”) and AEON Credit Service (M) Berhad (“AEON Credit”) (AEON BiG and AEON Credit are jointly described herein as “the Organisers”). This contest will be commencing from 5th October 2018 to 31st December 2018 (“Contest Period”). Any entries after the Contest Period shall not be entertained by the Organisers.
- 1.2 By participating in this Contest, you agreed to be bound by all the terms and conditions below (‘Terms and Conditions’).

2.0 Contest Eligibility

- 2.1 This Contest is open only to AEON Member Plus Visa Cardholders (“Eligible Cardholders”).
- 2.2 Participants must be a citizen or permanent resident of Malaysia who is currently residing in Malaysia and above the age of 18 years of old on or before 5th October 2018 (“Participants”).
- 2.3 This Contest is available at all AEON BiG hypermarkets nationwide.
- 2.4 The Organisers reserve the right to reject any entries or disqualify any Participants without assigning any reason.
- 2.5 AEON BiG and AEON Credit’s employees (including its respective subsidiaries), agencies, dealers, distributors, sponsors and respective immediate family members are not eligible to participate in this Contest.
- 2.6 To participate in this Contest, Eligible Cardholders are required to perform a minimum retail purchase of RM60 in a single receipt at any AEON BiG hypermarkets nationwide. (“Purchase Criteria”).
- 2.7 Upon meeting the Purchase Criteria, Participants are required to sign up a one-time online entry form at AEON BiG’s official website by providing their Personal Information and a creative slogan. Subsequent entries that meet the Purchase Criteria will be recorded digitally throughout the Contest Period.
- 2.8 **Multiple Entry**

3.0 Prizes

4.2 At the end of the contest period, 1,326 winners will be randomly selected from all eligible digital entries recorded by the Organisers.

4.3 All Grand Prize winners will be contacted by the Organisers within three (3) months after the contest period ends and the judges will attempt to contact the winning contestant up to two (2) times during regular business hours via phone. The Organisers shall not be held accountable in the event if the shortlisted winners cannot be contacted for whatsoever reason.

4.4 All Grand Prize winners are required to produce a valid Class D driving license, original identification card and other supporting documents which may be required by the Organisers ("the Required Documents").

4.5 All winners for Grand Prize will also be invited to a 'Prize Giving Ceremony' which the details of the event shall be confirmed by the Organisers. Failure to comply to produce the Required Documents or attend the 'Prize Giving Ceremony' will cause the prize to be forfeited and the Organisers reserve the right to substitute with another winner.
